## Health & Sanitary Regulations—Bubble Concept

### 1. General Policy on Exit and Entry Management

All Test Event participants need to conduct a daily health monitoring for the 14 days before departure for China. They must provide true and actual information on their health status and update such information accordingly. They must declare that they have no contact with any person infected with COVID-19 and no symptoms of fever, malaise, cough, sore throat, headache, muscle/joint aches, dyspnea, chest pain, vomiting, diarrhea, abnormal taste, etc. If any symptoms of COVID-19 arise within 14 days prior to departure, please go to local hospital for a nucleic acid test, and if participants cannot rule out the possibility of suffering from COVID-19 or other infectious diseases, they are highly not recommended to travel.

All participants from abroad are required to minimize their stay in China. They are required to leave China at the earliest convenience after the completion of the OWG Test Event. Nucleic acid testing services and test proof will be provided to persons who may need them before departure from China. A more detailed protocol will be made available in due course.

### 2. Entry Management Policy for Test Event participants

A category-based management and relative prevention and control measures will be implemented for all related personnel of Test Event.

Athletes should be vaccinated and get vaccinated ASAP. Unvaccinated athletes shall provide document stating the reason and a diagnostic report to the LOC before October 20, 2021. One IgM test should be performed for those not fully or not vaccinated.

All athletes who can be vaccinated shall get full vaccination at least 14 days before departure for China. Other events participants from overseas are required to get fully vaccinated as well. Vaccination certificates for vaccines approved by international, national or regional health authorities will be accepted. Those who choose not to be vaccinated shall come to China 21 days in advance for compulsory quarantine.

All participants shall send a scanned copy of vaccination certificate and Appendix-3. Vaccine Information to the Organising Committee at sjcoc2021@163.com before October 20, 2021. The documents will be finished reviewing by LOC before October 30, 2021.

Before boarding their flight for China, all participants are required to make a personal health declaration (as to whether they have been exposed to any person infected with COVID-19 and whether they have any symptoms of fever and/or cough).

For those who take a direct flight to China, please take one nucleic acid test at a testing agency at the departure city designated or recognised by the Chinese Embassy/Consulate within 72 hours before departure to China. Participants need to get the negative result for the Chinese Embassy/Consulate in the city of the testing agency reviewing and issuing the Green Health Code with HS logo or the electronic Health Declaration Form.

For those who take a flight with transfer(s), If the duration between the test and departure at the transfer airport does not exceed 72 hours, participants need to take one nucleic acid test at the city of departure to apply for the Health Code or the electronic Health Declaration Form. In such case no test is required at the airport of transfer. If the duration between the test and departure at the transfer airport exceeds 72 hours, or no test is taken at the city of departure, participants need to take one nucleic acid test at the city of transfer(s) within 72 hours before boarding the last leg of flight to China to apply for the Health Code or electronic Health Declaration Form.

Any previous COVID-19 infected participant should provide the latest positive nucleic acid test result and the first negative test result after recovery issued by a test agency/ medical institution in your country/region. If the participant's first negative test result after recovery is within 30 days, two additional nucleic acid test results will be taken at least 24 hours in between. Take one nucleic acid test and one IgM antibody test at a testing agency at the departure city designated or recognised by the Chinese Embassy/Consulate within 72 hours before departure to China. Those with first negative test results after recovery exceeding 30 days need to take one nucleic acid test at a testing agency at the departure city designated or recognised by the Chinese Embassy/Consulate within 72 hours before departure to China.

Participants are required to wear a medical protective mask (N95 or KN95 without valve) for the whole duration of flight, except when eating or drinking. Other personal protective measures such as wearing face shield or goggles and regular hand washing are encouraged.

At the first port of entry (primarily Beijing), if the body temperature tested is equal or higher than 37.3°C, the person concerned will be transported to a designated hospital for further testing, diagnose and treatment. Otherwise, they will go through a collection of nasopharyngeal swab for nucleic acid testing. After the sample collection, they will proceed through dedicated passages and directly go to the hotel by dedicated vehicles. Pending the test results, they must refrain from moving around in the hotel. They will be exempted from quarantine with the negative test result.



As a step to implement China's COVID-19 prevention and control protocols, Test Event participants must strictly comply with the COVID-19 prevention and control protocols and bubble-to-bubble administration measures in training, competition and other activities. They must not leave their residence, training or competition venues for participation of any event or activity unrelated to the Test Event. Daily health monitoring and nucleic acid test will be conducted regularly during their stay.

### 3. Bubble-to-bubble Management Policy

A bubble-to-bubble management policy will apply to all participants. Strict prevention and control measures will be applied in every step of their stay, including arrival and departure, transport, accommodation, food and drinks, training, competition, meetings and other events. They shall not go outside of the bubble, take public transport, or interact with people outside the bubbles. The same bubble-to-bubble management policy will also apply to Chinese athletes, officials, working and support staff who will or may have close contact with Test Event participants.

### 4. Emergency Response Policy

In case any person, object or environment is tested positive, an expert panel, which is composed of epidemic control and sports professionals, will conduct a prompt analysis and anyone who tests positive for COVID-19 should be transferred to the designated hospital for the isolation treatment immediately. The situation will be reported to the Organising Committee, FIS and related organisations and agencies and the panel will deal with such cases in a science-based, targeted and timely manner so as to promptly contain any potential spread of infections.

### 5. COVID-19 Control on an On-going Basis

During their stay in China, all participants are required to strictly comply with the prevention and control protocols, such as mask wearing, frequent hand washing, constant room ventilation, cleaning and disinfection, cough etiquette, and physical distancing. They are also required to accept the supervision and follow the advice and guidance of the Organising Committee staff.

## Entries

Entries will only be accepted from FIS member National Ski Associations in accordance with the FIS quotas and the rules for FIS Continental Cup Entries. Entries must be submitted to the OC within the mentioned deadlines using the FIS online entry system.

## Accreditation

The accreditation cards to all participants will be provided by LOC. The accreditation application form will be sent out at a later stage. Accreditation card is required to be checked to access lift, lounge, restaurant, shuttle bus and other facilities.

## Visa Regulations

In face of the global outbreak of COVID-19, the previous visa to China will be invalid, and a special visa will be required for this special period. Appendix-1. Visa Invitation Information Form has been sent to the NSAs together with this Information. It must be completed and sent to sjcoc2021@163.com upon completion by latest October 10, 2021. Please also send the ID Photos (refer to Appendix-2. Personal Photo Requirement) and scanned passport. Passport must be valid for at least six months. All NSAs are required to provide the LOC with the precise information of the athletes and all team members who will and probably participate at the Continental Cups ("Long List"), or the visa could not be issued. The visa will be issued ASAP.

## Flight Information

In principle, the participants may arrange itinerary on their own. Upon request, the Organising Committee will coordinate with domestic and foreign airlines to provide the most convenient designated flight options for the participants to come to China. The team that needs OC to coordinate the air tickets shall send the Appendix-4. Air Tickets Reservation Form to sjcoc2021@163.com by latest October 20, 2021. Participants shall arrive in Zhangjiakou not earlier than December 2, 2021 and leave Zhangjiakou on December 6, 2021. The cost of tickets should be covered by the participants.

## Accommodation

Official Hotel: Thaiwoo hotel (four-star hotel), Element by westin hotel (four-star hotel)

Within the quota: In accordance with the FIS COC rules, free accommodation will be provided.

Additional: CHF 125 per person per day for Single Bedroom. (including meals), CHF 100 per person per day for Double Bedroom. (including meals)

Facilities: The hotel lobby bar and dining hall will be available for free. Meeting rooms and laundry service will be available at an additional cost.

Meals: Buffets of breakfast, lunch and dinner will be provided for participants by hotel. Participants should have meals at the hotel. If participants have to dine in the venue due to competition schedule, meal packs of the same catering standard will be provided. According to the requirements of COVID-19 countermeasures, participants need to carry the lunch packs by themselves. Any special accommodation needs, please contact the LOC.

## Transportation

### Airport Shuttle Bus

On arrival and departure day, free shuttle bus between Beijing Capital International Airport (PEK) and the official hotel are available for the participants. Please specify your arrival in the Online Entry System. Carry-On luggage can be transferred together with shuttle bus, and large luggage can be transferred in special van.

### Venue Shuttle Bus

The free venue shuttle bus service will be provided between official hotel and the venue during December 2-6, 2021.

## Radio Frequency Spectrum & Equipment Regulation

All radio equipment brought from abroad to be used during the FIS Ski Jumping Continental Cup (Men & Women) 2021/2022 requires short-term frequency license from Ministry of Industry and Information Technology of China.

In order to obtain the radio frequency license, please complete the Appendix-5. Radio Channel Applicant Information enclosed in the invitation letter, and submit it to [sjcoc2021@163.com](mailto:sjcoc2021@163.com) via email by November 10, 2021.

Foreign corporations, organisations and individuals will not be charged for radio frequency application and usage fees for FIS Ski Jumping Continental Cup (Men & Women) 2021/2022.

All radio equipment, prior to being operated in China for FIS Ski Jumping Continental Cup (Men & Women) 2021/2022, shall be tested and tagged at specified locations.

When entering the venues for FIS Ski Jumping Continental Cup (Men & Women) 2021/2022 with radio equipment, the obtained frequency tag shall be presented consciously and actively. In case of radio interference, it is compulsory to cooperate with the work staff to identify and eliminate the interference.

For other requirements on radio frequency management for the test events, please refer to the "Spectrum Management Plan for the Beijing 2022 Olympic and Paralympic Winter Games", which can be downloaded from the official website of Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games.

## Insurance & Liability

All athletes, officials and other members of the national association who attend and participate in the event shall do so at their own risk. The Organising Committee shall not be responsible for any loss or injuries incurred or suffered by any athlete or official in conjunction with the Organisation or staging of the event.

Competitors must have their own medical insurance (ICR art 212). All participants shall pay for all medical treatment (including Covid-19 treatment) fee by their own expense.
